

PILOT CANDIDATE FLIGHT INSTRUCTION CHECKLIST

A pilot candidate shall have logged flight and/or ground instruction for this registration from a BFI covering at least the areas of operation contained in the Ultralight Pilot Written and Practical Test Standards Guide listed below. The candidate's logbook must contain an endorsement from a current BFI certifying that the person is proficient to pass a practical test on these areas of operation.

A pilot candidate's ability to perform the pilot operations will be evaluated with respect to his or her:

1. Execution of the procedures and maneuvers within the vehicle's performance capabilities and limitations, including use of the vehicle's systems.
2. Properly executing the appropriate procedures and maneuvers.
3. Handling the vehicle with smoothness and accuracy.
4. Exercising good judgment.
5. Applying aeronautical knowledge.
6. Showing mastery of the vehicle, with successful outcome of a procedure or maneuver never seriously in doubt.
